1. SCOPE OF FILMING & USE I, the undersigned, am the parent or legal guardian of the minor named above. I hereby grant Estiera Sport LLC, d/b/a Soccer IQ Network, (the "Company" or "Soccer IQ Network") and its agents permission to film, photograph, and record the minor's image, voice, and performance during athletic events.

I understand and agree that the footage and data captured will be used for:

- **Team & Individual Services:** Scouting reports, highlight reels, and performance analysis.
- **Public Platforms:** Uploading to public video and social media platforms, including but not limited to **YouTube, Instagram, and TikTok.**
- **Marketing & Promotion:** Use in the Company's website, social media channels, and promotional or marketing materials to showcase the Company's services.

2. STORAGE & SHARING

- **Storage:** Footage and related personal data (name, jersey number, stats) will be stored on secure, third-party cloud-based servers and the Company's internal drives.
- **Sharing:** The Company may share footage with the Client (the Sports Club/Team), college recruiters, and third-party automated processing services (for stat-tracking or AI tagging).

3. DATA SECURITY & PROTECTION (FIPA) In accordance with the **Florida Information Protection Act (FIPA)**, the Company implements reasonable administrative and technical safeguards to protect player data from unauthorized access. The Company will not sell the minor's personal information to third-party data brokers.

4. OPT-OUT & DELETION RIGHTS

- **Right to Decline:** I understand that participation is voluntary. I may decline this consent, in which case the Company will use commercially reasonable efforts (such as jersey number tracking) to avoid filming the minor.
- **Right to Delete:** I may request the deletion of my child’s footage or personal data at any time by providing written notice to Soccer IQ Network, at admin@socceriqnetwork.com AND to the minor’s specific sports team. Upon receipt of such notice, Soccer IQ Network will cease further collection and use commercially reasonable efforts to remove existing footage from its active platforms.
- **How to Exercise:** To opt-out or request deletion, I must send a written notice to Soccer IQ Network, at admin@socceriqnetwork.com AND to the minor’s specific sports team. Upon receipt, the Company will cease further collection of data and remove existing footage from public-facing platforms where technically feasible.

5. RELEASE & WAIVER. I RELEASE THE COMPANY FROM ANY CLAIMS ARISING FROM THE STANDARD USE OF THIS FOOTAGE IN A SPORTS OR PROMOTIONAL CONTEXT. I ACKNOWLEDGE THAT ONCE FOOTAGE IS SHARED ON PUBLIC SOCIAL MEDIA, THE COMPANY CANNOT CONTROL SUBSEQUENT SHARING BY THIRD PARTIES.

GOVERNING LAW. This Agreement shall be governed by the laws of Florida, without respect to conflict of law principles.
